



WEBSITE TERMS OF USE

PLEASE READ THESE PAXVAX WEBSITE TERMS OF USE ("TERMS OF USE") CAREFULLY BEFORE USING THIS WEBSITE (THE "WEBSITE"). THESE TERMS OF USE GOVERN YOUR ACCESS TO AND USE OF THE WEBSITE. THE WEBSITE IS AVAILABLE FOR YOUR USE ONLY ON THE CONDITION THAT YOU AGREE TO THE TERMS OF USE SET FORTH BELOW. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF USE, DO NOT ACCESS OR USE THE WEBSITE. BY ACCESSING OR USING THE WEBSITE, YOU AND THE ENTITY YOU ARE AUTHORIZED TO REPRESENT ("YOU" OR "YOUR") SIGNIFY YOUR AGREEMENT TO BE BOUND BY THE TERMS OF USE.

- 1. User Eligibility.** The Website is provided by PaxVax, Inc. ("PaxVax") and available only to entities and persons over the age of legal majority who can form legally binding agreement(s) under applicable law. If you do not qualify, you are not permitted to use the Website.
- 2. Scope of Terms of Use.** These Terms of Use govern your use of the Website and its content (the "Content") available on the Website.
- 3. Modifications.** PaxVax may revise and update these Terms of Use at any time. Your continued usage of the Website after any changes to these Terms of Use will mean you accept those changes. Any aspect of the Website may be changed, supplemented, deleted or updated without notice at the sole discretion of PaxVax. PaxVax may also change or impose fees for products and services provided through the Website at any time in its sole discretion.
- 4. PaxVax Privacy Policy.** The PaxVax Privacy Notice governs the use of information collected from or provided by you at the Website. [Privacy Notice Hyperlink](#).
- 5. License.** PaxVax grants you a limited, personal, nontransferable, non-sublicensable, revocable license to access and use only the Website and Content for your own personal, non-commercial use, only in the manner presented by PaxVax. Except for this limited license, PaxVax does not convey any interest in or to the Content, Website or any other PaxVax property by permitting you to access the Website. Except to the extent required by law or as expressly provided herein, none of the Content or Website may be reverse-engineered, modified, reproduced, republished, translated into any language or computer language, re-transmitted in any form or by any means, resold or redistributed without the prior written consent of PaxVax. You may not make, sell, offer for sale, modify, reproduce, display, publicly perform, import, distribute, retransmit or otherwise use the Content in any way, unless expressly permitted to do so by PaxVax.
- 6. Ownership.** Any and all intellectual property rights ("Intellectual Property") associated with the Website and its Content are the sole property of PaxVax, its affiliates or third party licensors. - 7. Restrictions on Use of the Website.** In addition to other restrictions set forth in these Terms of Use, you agree that: (a) you will not use or access any Content available via the Website in a manner not

expressly permitted by PaxVax; (b) you will not input or upload to the Website any information which contains viruses, Trojan horses, worms, time bombs or other computer programming routines that are intended to damage, interfere with, intercept or expropriate any system, the Website or Information or that infringes the Intellectual Property (defined below) rights of another; (c) you may not use or access the Website in any way that, in PaxVax's judgment, adversely affects the performance or function of the Website or interferes with the ability of authorized parties to access the Website; and (d) you may not frame or utilize framing techniques to enclose any portion or aspect of the Content or the Information, without the express written consent of PaxVax.

Governing Law and Language.** To the fullest extent permitted by law, these Terms of Use are governed by substantive laws of the State of Delaware, U.S.A. excluding (i) Delaware's conflicts of laws principles; (ii) the United Nations Convention on Contracts for the International Sale of Goods; (iii) the 1974 Convention on the Limitation Period in the International Sale of Goods; and (iv) the Protocol amending the 1974 Convention, done at Vienna April 11, 1980. To the fullest extent permitted by law, the controlling language for these Terms of Use is English.
- 15. General.** You may not assign these Terms of Use or any of your interests, rights or obligations under these Terms of Use. If any provision of these Terms of Use is found to be invalid by any court having competent jurisdiction, the invalidity of such provision will not affect the validity of the remaining provisions of these Terms of Use, which will remain in full force and effect. No waiver of any of these Terms of Use is deemed a further or continuing waiver of such term or condition or any other term or condition. If you make any claim against any of our affiliates or licensors they are entitled to rely on your representations, warranties and covenants in these Terms of Use to the same extent as if they were a direct party to them with you.
- 16. Complete Agreement.** Except as expressly provided in a separate written agreement between you and PaxVax, these Terms of Use constitute the entire agreement between you and PaxVax with respect to the use of the Website and Content contained therein, and supersede all discussions, communications, conversations and agreements concerning the subject matter hereof.
